## governing principles

We, the sitting Elders on the Session of Valley Presbyterian Church, are seeking to discern God's will and direction for our congregation on the issue of ordination standards for ruling and teaching Elders and Deacons.

According to the Book of Order (the constitution of the Presbyterian Church-USA), the ruling Elders are "chosen by the congregation to discern and measure its fidelity to the Word of God, and to strengthen and nurture its faith and life." These will be the primary guidelines we seek to follow as this decision is considered (G-2.0301).

As part of this effort, we are inviting the congregation to study the issue and provide input to our decision making process. We will present all views as fully and fairly as we can. We expect this to be a process in which we listen carefully and speak in love to each other, as fellow disciples of Christ.

The final decision will be the result of a vote of sitting members of the Session, which will take place later in the year. While congregational input is valued, the congregation will not vote on this issue, per the Book of Order, which spells out the functions of the congregation as a whole in section G-1.0503\*.

After a decision is made, we will remain a congregation of Christian disciples who have been blessed by God with many resources and talents to carry out Christ's work in this world.

\*Business to be transacted at meetings of the congregation shall be limited to matters related to the following: electing ruling Elders, Deacons, and Trustees; calling a pastor, co-pastor, or associate pastor; changing existing pastoral relationships; buying, mortgaging, or selling real property; requesting the Presbytery to grant an exemption; approving a plan for the creation of a joint congregational witness, or amending or dissolving the joint congregational witness.

### Mark Achtemeier, Ph.D.

From the Westminster John Knox Press website:

Mark Achtemeier, Ph.D., has served the Presbyterian Church (U.S.A.) since 1984 as a pastor, writer and theologian. He taught theology and ethics for 15 years on the faculty of Dubuque Theological Seminary.

Formerly a conservative church activist and opponent of lesbian, gay, bisexual, and transgender (LGBT) inclusion, over a period of years he underwent a change of heart not in spite of the Bible's message but because of it. He is now an outspoken advocate of LGBT inclusion. He makes the case that embracing gay marriage and LGBT inclusion represents a true and faithful application of the Bible's teaching on marriage and sexuality rather than its contradiction. In this advocate role, he has testified before Congress on gay rights and been a leading voice for a more inclusive church. He is married to the Rev. Katherine Morton Achtemeier, and together they have three grown children.



### Marianne Meye Thompson, Ph.D.

George Eldon Ladd Professor of New Testament

Marianne Meye Thompson, the George Eldon Ladd Professor of New Testament, joined the School of Theology faculty in 1985.

Thompson has been instrumental in developing advanced-level interdisciplinary courses that integrate biblical interpretation with other disciplines of the theological curriculum. She is author of 1–3 John (IVP New Testament Commentary, 2011), *A Commentary on Colossians and Philemon* (The Two Horizons Commentary, 2005), *The God of the Gospel of John* (2001), *The Promise of the Father* (2000), and co-author of *Introducing the New Testament* (2001). She has also published numerous articles and reviews in scholarly journals. She is currently working on a commentary on the Gospel of John.

### Dr. Robert A. J. Gagnon

Associate Professor of New Testament Pittsburgh Theological Seminary

Gagnon's main fields of interest are Pauline theology and sexual issues in the Bible. He is a member both of the Society of Biblical Literature and of the Studiorum Novi Testamenti Societas [Society of New Testament Studies]. He is also an ordained elder at a Presbyterian Church (USA) in Pittsburgh. He is an author and provides a large amount of free material on the web dealing with Scripture and homosexuality. In addition, he has been quoted in, or has written for, the New York Times, National Public Radio, CNN, U.S. News and World Report, Christianity Today, Christian Century, and other news outlets and popular magazines.



### J. R. Daniel Kirk, Ph.D.

Associate Professor of New Testament, School of Theology

Daniel Kirk joined Fuller in 2008 as a faculty member at the Northern California regional campus in Menlo Park, having previously taught at Biblical Seminary and Duke Divinity School, as well as several undergraduate institutions.

A member of the Society of Biblical Literature, Kirk's primary academic interests revolve around reading Jesus and Paul in their Jewish and Roman contexts as a first step toward understanding Scripture and enriching the church. His publications include articles in Journal of Biblical Literature, Journal for the Study of the New Testament, Catholic Biblical Quarterly, and Zeitschrift für Neues Testament. He is the author of *Unlocking Romans: Resurrection and the Justification of God* and *Jesus Have I Loved, But Paul? A Narrative Approach to the Problem of Pauline Christianity.*

Ron indicates that "Over the years, one thing I've been told consistently is that I have a "pastor's heart". I love people and love to encourage their faith in the God of all Comfort."
